Sub: Adi Dravidar and Tribal Welfare Department – Tribal Welfare – Establishment – Functioning of Tribal Directorate – Requirement and allocation of additional Staff – Requisition for grant of extension of 1 month period for implementation of the G.O - Reg.

I invite your kind attention to the references cited.

2. In the reference 2<sup>nd</sup> cited orders were issued regarding, administrative / establishment control and financial powers of all tribal welfare related schemes, GTR Schools and Hostels to the Director, Tribal Welfare, in which willingness of the Officers, Teachers, Wardens and other officials who were working in the Directorate of Tribal Welfare has to be obtained and final decision will be concluded within 6 months by the both the Directorate of Tribal Welfare, their willingness may be considered based on their seniority. Further, within 6 months if nobody can opt their willingness to work under the Directorate of Tribal Welfare, tribal related subjects and establishment matters, will automatically come under the full administrative control of the Director, Tribal Welfare.

3. In the reference 3<sup>rd</sup> cited, the Director, Tribal Welfare stated that the Director, Adi Dravidar Welfare is requested to allot teachers to GTR Schools after seeking their preferences which is under process. Six months time allowed to implement the G.O. reference 2<sup>nd</sup> cited and will expire by February 28<sup>th</sup> 2018, but the process of transfer to establishment of schools and Directorate is still pending. More over as the financial year and academic year is nearing end all the activities are in final implementation stages. So a transfer of establishment on March 1<sup>st</sup> 2018 may hamper the implementation of works. Hence, the Director, Tribal Welfare has requested that the time limit prescribed for implementation of G.O. may be extended by 1 month, so that he can take over all the activities and establishment related to tribal welfare by 1<sup>st</sup> April 2018, on the first day of next financial year.

4. After careful examination, the Government accept the proposal of the Director, Tribal Welfare and grant further 1 month period for implementation of G.O. vide reference 2<sup>nd</sup> cited for taking over all the activities and establishment matters related to tribal welfare by 1<sup>st</sup> April 2018, on the first day of next financial year.
